1. The National Wages and Productivity Commission (NWPC), per National Expenditure Program CY 2020, intends to apply the sum of P 1,600,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Security Service for January 1 to December 31, 2020. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NWPC now invites bids for Procurement of Security Service for January 1 to December 31, 2020.

Delivery of Goods is required on January 1 to December 31, 2020. Bidders should have completed, within a 3-year period from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from NWPC and inspect the Bidding Documents at the address given below during office hours from 8am – 5pm.

5. A complete set of Bidding Documents may be purchased by interested Bidders on 18 November 2019, Monday from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of P 1,000.00.

6. The NWPC will hold a Pre-Bid Conference on 22 November 2019, Friday, 11:00 am at 2/F NWPC Conference Room (address below), which shall be open to all interested parties.

Bids must be submitted to the address below on or before 06 December 2019, Friday, 1:00 pm. All Bids must be accompanied by a bid security in Manager's/Cashier's cheque in the amount stated in ITB Clause 18 (Bid Security) or Bid Securing Declaration Form (GPPB Resolution No. 25-2013 and 13-2014).

Bid opening shall be on 06 December 2019, Friday, 1:30 pm at 2/F NWPC Conference Room (address below). Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

7. The NWPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
