> Responsibilities of Distributors:

- Pick-up of corporate giveaways from NWPC
- Transport of corporate giveaways to selected high-volume stations
- Distribution of corporate giveaways to MRT riders
- Photo documentation of distribution done
- Comply with RT-PCR & full PPE requirement

> Other Requirements:

- Twelve (12) lots RT-PCR testing prior to distribution (month 1) (PHP 45,600.00)

- Twenty-four (24) Rapid antigen testing prior to distribution (months 2 & 3) (PHP 23,040.00)
- Thirty-six (36) Wearing of full PPE gowns during distribution on top of the required facemasks and face shields (12 workers per month for 3 consecutive months) (PHP 10,800.00)
- Seventy-two (72) Wearing of gloves for AM and PM distribution (12 workers with 2 sets of gloves per month for 3 consecutive months) (PHP 360.00)
