2. Valid and current License to Operate (LTO) for drug suppliers, distributors and traders issued by Philippine Food

and Drugs Administration (PFDA).

3. Product Insert/Product Information or downloaded from the internet and other manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate for cross-referencing statement of compliance to the technical specification.

4. The bidder shall submit any of the following whichever is applicable:

- a) If the bidder is a manufacturer, certificate that the bidder manufactures the products/item; or
- b) If the bidder is an Exclusive/Authorized Distributor or Dealer of the products/items, Certificate or Contract from the manufacturer or importer must be provided as proof that the bidder is an Exclusive/Authorized Distributor or Dealer of the products/items; or
- c) If the bidder is an agent of the exclusive distributor or dealer, the following must be provided:
 - i. Certificate or Distributor/Dealership Agreement by the Manufacturer with the distributor or dealer; and
 - ii. Contract between the distributor/dealer and the bidder.

Submit/attach complete valid procurement documents (preferably in Portable Document Format/PDF) as required by 2016 Revised Implementing Rules and Regulations of RA 9184 and other GPPB issuances upon submission of quotation:

1. Mayor's Permit and PhilGEPS registration number upon submission of quotation;
2. For Omnibus Sworn Statement, only Bidders found compliant with initial submissions shall be required to submit said document within two (2) days from notice.
