Description

INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF SIXTY-EIGHT (68) UNITS LAPTOP

1. The National Wages and Productivity Commission, through the General Appropriations Act FY 2025 intends to apply the sum of Six Million Six Hundred Twenty-Four Thousand Pesos (PhP6, 624, 000.00), inclusive of all taxes, being the ABC to payments under the contract for Supply and Delivery of Sixty-Eight (68) Units Laptop for each lot with Project Identification PB No. 2025-03-012, to wit:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The National Wages and Productivity Commission now invites bids for the above Procurement Project. Delivery of the Goods is required within sixty (60) calendar days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is

contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the National Wages and Productivity Commission - BAC Secretariat and inspect the Bidding Documents at the address given below from Mondays to Fridays at 8:00 A.M to 5:00 P.M.

5. A complete set of Bidding Documents may be acquired by interested Bidders starting March 28 to April 18, 2025 at 8:00 A.M to 5:00 P.M and April 21, 2025 until 1:00 P.M. from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP10, 000.00 in accordance with the following schedule:

The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

The payment of bidding documents fee shall be made to the National Wages and Productivity Commission – Cashier located at the 11th Floor, Trium Square, Sen. Gil J. Puyat Avenue, Pasay City, 1306 Metro Manila.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

6. The National Wages and Productivity Commission will hold a Pre-Bid Conference on April 04, 2025, at 1:00 P.M at NWPC Conference Room, 11th Floor, Trium Square, Sen. Gil J. Puyat Avenue, Pasay City, 1306 Metro Manila and/or through video conferencing or webcasting, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before April 21, 2025, at 1:00 P.M. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14 otherwise, the bid shall be rejected by the BAC and rated as non-responsive to eligibility requirements.

9. Bid opening shall be on April 21, 2025, at 1:30 P.M. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. All documents shall be current and updated and any missing documents in the checklist is a ground for outright reject of the bid. Bidder shall submit one (1) original of the first and second components of its bid envelope in a sealed envelope.

Facilitate the evaluation of the bids, bidders are advised to follow the arrangement in the checklist when placed in an envelope, with documents bounded, tabbed and labeled accordingly.

11. The National Wages and Productivity Commission reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

12. Any request for clarification(s) on any part of the Bidding Documents must be in writing and submitted to BAC Secretariat via email at least ten (10) calendar days before the deadline set for the submission and receipt of Bids or before 4:00 P.M. on April 11, 2025. Should there be revisions in the Bidding Documents, a corresponding Bid Bulletin shall be issued not later than April 14, 2025.

13. Please be reminded of the "no contact rule" under Section 32.1 of the 2016 IRR of R.A. No. 9184, i.e., bidders whose bids are being evaluated are prohibited to make any communication with any member of BAC-GS for SC, including its staff and personnel, as well as its Secretariat and Technical Working Group (TWG) until the issuance of the Notice of Award. On the other hand, a disqualified bidder may provide valid, reasonable and lawful information on matters pertaining to the bids being evaluated, provided that such bidder has no pending request for reconsideration or protest relative to his/her disqualification.
